<p><b>2. Categories of personal data</b></p>	<p>The Joint Controllers shall process personal data belonging to the following categories of data subjects:</p> <ul style="list-style-type: none"> <li>- university students including those who are enrolled at the MASS Programme;</li> <li>- teaching staff (professors and/or researchers);</li> <li>- technical, administrative and library staff;</li> <li>- other data subjects outside the Joint Controllers' community. In particular, the following data shall be processed:</li> <li>- personal data (name, surname);</li> <li>- audio, video or photographic material in which the data subject appears, is represented, or in any case recognizable ("portrait"), as part of the MASS Programme activities.</li> </ul>
<p><b>3. Source of personal data</b></p>	<p>The personal data listed above shall be collected directly from the data subject.</p>
<p><b>4. Purposes of data processing and legal basis</b></p>	<p>The data processed shall be collected and used for the <b>publication and/or dissemination for the purposes of institutional communication and promotion of the Joint Controllers.</b></p> <p>The publication/dissemination of the portrait may take place:</p> <ol style="list-style-type: none"> <li>1) on websites belonging to the MASS programme and to the Joint Controllers web system (for example, on the Joint Controllers' institutional sites and on other sub-domains);</li> <li>2) on the social channels of the MASS programme and of the Joint Controllers (e.g. Instagram, Facebook, X (former Twitter), Telegram and YouTube);</li> <li>3) on print paper and/or any other means of diffusion/publication (i.e. web, blogs, newsletters, etc.);</li> </ol>

	<p>4) in promotional banners, on posters paper, billboards, advertisements, information materials, brochures and leaflets.</p> <p>Consent to the personal data processing shall be collected by filling in this form, pursuant to article 6 par. 1 lett. a) “<i>consent data subject</i>”. The consent may be revoked at any time by writing to the address <a href="mailto:project-office@master-mass.eu">project-office@master-mass.eu</a>. The consent revocation of processing personal data for print media is possible only for new editions due to the disproportionate effort involved in removing photos from printed products. The Joint Data Controller does not use automatic processes aimed at profiling the data subject.</p>
<p><b>5. Categories of recipients of personal data</b></p>	<p>Within the limits of the processing purposes indicated, the data shall be communicated and/or in any case made accessible to employees and collaborators in charge of the competent offices of the Joint Controllers, in their capacity as subjects authorized to process data and to other Joint Controllers’ offices for institutional purposes or for compliance with legislative obligations.</p> <p>In the event that the data referred to in point 2 are transmitted to third parties who carry out processing on behalf of the Joint Controllers, they shall act as Data Processors pursuant to Article 28 GDPR. The data may be processed by all internet users visiting the relevant websites” and “readers/viewers of the printed material” containing the said photos or similar within the scope of the purposes described in point 4.</p>
<p><b>6. Data retention period</b></p>	<p>The personal data collected shall be kept for a period of time not exceeding the purposes for which they shall be processed.</p> <p>In particular, the images, audio and video recordings of the data subjects shall be kept for ten years from the conclusion of the event on the occasion of which they were collected, without prejudice of their storage through the permalinks in use on specific social media (e.g. Facebook).</p>
<p><b>7. <p><b>8. Obligation to provide personal data</b></p>	<p>The provision of data is optional. Failure to consent shall not allow the use of images and/or audiovisual filming and/or audiovisual recordings of the data subject for the purposes stated above.</p>

Data processing methods</b></p>	<p>The personal data provided shall be subject to processing operations in compliance with the above-mentioned regulations and the confidentiality obligations that inspire the activity of the Data Controller. The personal data shall be processed both by computer and on paper and on any other suitable type of sup-</p>

	port, in compliance with the appropriate security measures pursuant to Article 5(1)(f) GDPR.
<b>10. Transfer of personal data to non-EU countries</b>	The personal data may be transferred to third countries, in compliance with the provisions of Chapter V of the GDPR (Articles 44-50). In particular, the personal data collected shall be transferred to the University of Belgrade, as Full Partner of the EMJM-MASS throughout the “Standard Data Protection Clauses” adopted by the European Commission in accordance with article 46 of the GPDR.
